
Chief of Long Range Planning / Manager of Comprehensive Planning, October 1985 to May 1989

After Florida adopted the Growth Management Act of 1985, I became a local government planner charged with preparation of a growth management plan. My role was to guide the content of the plan, serve as chief author of the future land use element, and make presentations at community meetings, public workshops, and public hearings.

The planning process was challenging; ultimately, consensus was reached around the following planning objectives:


- Urban development boundaries
- Reduced densities in coastal-high hazard areas
- Tiered activity centers
- Access management and corridor design standards
- Incentives for affordable housing

- Watershed-based planning
- Natural resource protection areas
- Zoning revaluation
- Community plans for Immokalee, Golden Gate Estates and Marco Island



After a three-year effort, the County Commission adopted a Growth Management Plan that received Excellence awards from the Florida Department of Community Affairs and the National Association of Counties. The county has since grown from 115,000 to more than 370,000 yet the framework for growth remains largely intact.

I also managed an Immokalee Area Master Plan process. Because of our work, Collier County modernized its zoning and building codes, initiated targeted code enforcement to reduce blight, upgraded public safety services and improved housing through a farmworker housing plan. The Immokalee initiative turned a spotlight on the community, activated public involvement and achieved tangible improvements.



Anxious for private sector experience, I decided to leave my job with Collier County.

I returned to the public sector to serve as a principal planner and zoning manager for neighboring Lee County. This was during a period of explosive growth that saw a high volume of large scale zoning changes. Lee County used a quasi-judicial Hearing Examiner system so I became familiar with sworn testimony and cross-examination. Every other Tuesday I presented an agenda of re-zoning recommendations to the County Commission – over 300 cases all told - decisions I helped craft have shaped Lee County, which has since more than doubled in population.

It was an honor to play a role in the planning for Florida Gulf Coast University, expansion of Southwest Florida International Airport, controversial marina proposals on Estero, Pine and

Gasparilla Islands, commercial down-zonings to protect the character of Captiva Island, and a multitude of master planned developments.


As Bureau Chief, I had statewide responsibility for the review of comprehensive plans, developments of regional impact, and areas of critical state concern.

Director Division of Community Planning, January 2007 to April 2011

During this time, I was responsible for all facets of Florida's Growth Management Program and became more involved in interagency planning initiatives, the governor and cabinet and legislative affairs.

Comprehensive Plan Review

With Florida's rapid growth and real estate bubble the volume of comprehensive plan amendments was enormous. As a Growth Management Administrator, 724 local government amendment packages crossed my desk for formal state review; as Bureau Chief, there were 1,870 packages; as Division Director, another 2,500 packages. All told, I played a leadership role in assuring that over 5,100 comprehensive plan amendment packages met the standards of Chapter 163, Florida Statutes. Between 2007 and 2011, future land use map amendments reviewed by our office affected nearly one million acres of land and provided for more than one million new homes and 2.7 billion square feet of non-residential floor area.



Most rewarding was assisting publicly initiated planning efforts. I worked with county and city planners to share ideas and resolve issues early on in a way that met state requirements while preserving local creativity. For example, the Palm Beach County Managed Growth Tier System, the Miami 21 Blueprint for the 21st Century, the Sarasota 2050 Plan, the St. Lucie County Towns, Villages and Countryside Plan, the Osceola County Growth Smarter Plan, the Taylor County 2060 Vision Plan, and the Alachua County 2030 Plan.
